Voting Procedures

The only persons allowed to participate and vote are representatives of ICA member organisations who have submitted a duly filled **<u>nomination form</u>** signed by a <u>member organisation</u> of the ICA 6 weeks before the Annual Plenary Meeting (17 August 2022).

Should a representative not be able to attend the meeting, they can submit a proxy in writing to the Youth Committee secretariat (<u>hacquard@ica.coop</u>). For a current list of representatives who you could give a proxy to, please ask the secretariat. A sample proxy letter is provided below:

Representatives will be automatically registered using their unique email on record by the secretariat in zoom and in the electronic voting system. The joining details will be sent directly by zoom to participants a few days before the APM. Instructions on how to vote and registration in the electronic voting system will also be sent a few days before the election. It will be important for representatives to activate their voter account before the APM.

All votes will be by show of hand online, except for the election for the Executive Committee. The election of the Executive Committee will take place using a separate online secret digital voting system. This election will be open for 24 hours from the time when the election begins. Access information to vote will be emailed separately to each voter.

The results will be announced via email on 30 September.

Youth Committee Work Plan 2022-2026

During the last four years a lot has been accomplished in the Youth Network both at the work level and at the ICA structural level. We are at a moment where despite the global circumstances to which we are not immune, we have managed to gain positive inertia.

The current global crisis and conflicts have shown us that there is unpredictable waiting around any corner. Yet, we have built a plan that will set the guides for this new youth committee to have a vision and a direction towards which we will set out efforts.

In order to generate an inclusive plan that is meaningful and inspiring for all the members we have passed a survey and the results of that survey have also been taken into account in this action plan.

Youth Visibility, belonging and representation

The youth committee's aim in this cycle of work is to strengthen the position of youth in the cooperative movement in general and to work in the presence and the involvement of the youth in the network and the structures of the ICA. To foster a sense of belonging and make this youth committee and network a reference for cooperative youth and cooperative networks looking for youth.

In the previous cycle three different kinds of youth where identified that will continue to be relevant to this cycles activity:

<u>Working youth.</u> Young people that work in the cooperative movement but although they are potential key members of their organization and could be a great representative for the youth movement, they aren't yet engaged in the youth activity. These are very interesting because they can be supportive of their non-youth fellow cooperators that already take part in the ICA activities.

<u>Entrepreneurs.</u> Those who are young create cooperative ventures and work to promote this form of entrepreneurship among youth in different sectors. These are normally the ones that take most of



the attention because they tick a lot of boxes when it comes to "empowerment" but they are "just" one out of three in our categories.

<u>Potential Cooperators.</u> Those people that believe in the cooperative principles but aren't part of the movement yet, they can become one of the two categories mentioned above. But also those that do not know about the movement just yet and that as youth committee and representatives we should work to reach and engage during these years.

In the previous cycle there was a strong activity in the mapping and identification of youth lead cooperatives worldwide and the creation of a toolkit to foster youth cooperative entrepreneurship.

In this cycle the youth committee plans to keep the effort but there will also be a big effort on identifying youth cooperators in existing cooperatives and in the involvement of these current and potential members in the activities of the network.

There will also be a big effort on the strengthening of the regions and the national activity to generate stronger regional platforms. There are many countries that have organizations in the ICA and yet do not have members in the youth network. This cycle will also focus on incorporating young cooperators and enforce geographical presence. There will also be a big support to generate national level youth networks that would ensure representativity and participation and widen diversity.

This identification of youth within the current members organizations of the ICA would allow the youth network and committee to grow as well as to become stronger in the positioning. Highlighting also the power of the national and regional movements to strengthen the global network in a distributed decentralized manner when generating action, initiatives and local and regional development. Visibility, empowering and engagement of youth in organizations in every sector will encourage participation of this youth in national, regional and international structures as well as participation in panels and events, raising the voice of youth as experts and opinion generators.

The strengthening of the network and the empowerment of its members will generate activity and visibility for cooperative youth and youth lead initiatives leading to a re-valorisation of the youth contribution. Members of the youth committee and network, and the organization itself, will raise their profiles in the cooperative movement and beyond.

Trends and verticals

As stated before, youth is present in every sector, but through these years I would really like to stress the work on three verticals that I think impact the whole movement on a greater scale.

<u>Education and Training.</u> To have more cooperatives we need entrepreneurs. To generate better projects within existing cooperatives we need intrapreneurs. In short, we need more cooperators. And these do not "pop out of nowhere". Cooperators are made and training and skill building is one of the main ways of fostering it. Many young people don't create or don't feel their coops, not because they aren't aligned with their values, but because they don't know of their existence. This is a work that we should be looking into in the next few years.

Previous projects such as *GYF20/GYF21* have proved the eagerness of the youth constituency to learn and share knowledge in different set ups. This year will keep up with the work of strengthening the network and the ability of young cooperators to learn together.

Education and training will allow connection among young cooperators which will most likely lead to peer support and empowerment. Youth connection will be encouraged and supported by the youth



committee in order to establish long standing spaces for dialogue and sharing in informal digital and online spaces.

The goals will be:

- To have a physical global youth gathering for youth cooperative empowering and training, *GYF*.
- To have a youth cooperative leadership and training program to empower and train young leaders worldwide and support their engagement in cooperative organizations and structures.

<u>Cooperative entrepreneurship.</u> Linked to the point above. To generate jobs and wealth, there needs to be work. This vertical has already been worked on in the previous cycle, with projects like the *Replication Project* that supported the funding and creation of 8 projects in the four regions and 1 project in two regions. More projects like this should be encouraged and the usage of the youth network to prototype potential entrepreneurial projects to set an example in the wider cooperative movement is a great vision.

The goals will be:

- To generate more activity and projects related to youth leadership and empowerment within the movement. To generate a *Replication project*, program that enables new youth lead cooperatives to succeed and be developed.
- Related to cooperative youth leadership program, to generate an online training program in line with the already existing *Toolkit* and the Coops4Dev *Youth and cooperatives, a perfect match?* report to share the knowledge in cooperatives and youth.

<u>IT and Tech.</u> In so many forums youth and digital are like magnets, they tend to stick to the other. Maybe it is the closeness to technology, the generational change or maybe it is just a belief. But it is very true in so many forums. During the last year, there has been a growing number of young people that have created or visualised their tech cooperative, creating an international network and developing projects together.

This is a field that will grow and will create jobs and wealth and as youth we should be part of the movement as it will not only generate revenue but shape the reality we live in and thus, the cooperative identity and model as we know it.

The goals would be:

- To generate an "expert group" that can (co)lead the dialogues and participate in the spaces generated by the ICA in the various digitization and digital development topic. This group can serve as touching point for the international cooperative organizations within the ICA and beyond.
- To generate a vision and a shared understanding of what cooperative technology means to the youth network and what are the spaces, enforcement, values and influences it enforces in the cooperative movement and identity.

Approval of the Minutes

The approval of the minutes will be conducted by show of hand. The Chair will give the opportunity for members to express their vote in favour, against or to abstain.



Youth Network Assembly 2019 Draft Minutes 13 October 2019 Kigali, Rwanda

Opening of the Assembly and Welcome from the Chairperson

Sébastien Chaillou thanked all of the participants for attending this important meeting.

Given that there were only 25 members represented in person or by proxy out of 79, a quorum of members was not reached. Therefore, the President closed the Assembly, and then re-opened it by suspending the quorum requirement. This motion was approved by the Assembly.

However, upon clarification of the ICA Youth Network constitution, this was unnecessary because Article VIII (meetings), item c states:

The quorum for a meeting shall be simple majority of those present in the assembly (more than half of the members (including those absent who are voting by proxy and those present but abstaining from that particular vote)).

Therefore, this motion to close and then reopen the meeting by suspending the quorum requirement, is rescinded.

Youth Committee Annual Plenary Meeting Election Results Youth President Online in April 2022

The election for the Youth President took place electronically starting from 11 to 16 April 2022, for a six-day time period (Monday-Saturday).

On Wednesday 6 April at 14:30 CET Brussels time, a webinar was held so that representatives could meet all the candidates during a live webinar.

Ana Aguirre was elected as the Youth President with 53 votes out of a total of 68 votes. 7 votes were considered invalid.

Executive Committee Elections

The Executive Committee has four seats for members at large who are nominated by ICA members, but no more than one member at large from each region. The Executive Committee members at large are elected every four years, so the candidates will fill the seats until the full election at the Annual Plenary Meeting in 2026.

It is not necessary for a nominee to be present in order to win the election. The Elections Committee would like to remind members of the following qualifications:

Candidates for the position must:



- Have full financial support from their nominating organisation that would pay for all the expenses of the person to be nominated. The budget should envision one meeting inperson per year.
- Take part in regular electronic meetings of the Executive Committee.

The Youth Committee recommends, based on past experience, that candidates:

- Be able to speak and write in English, but not exclusively, in order to facilitate communication. Executive Committee members must arrange for their own interpretation if they do not speak English.
- Have knowledge of youth issues, youth participation and the cooperative movement.
- Be able to convey and amplify the views of youth and their diversity at the global level. Be able to use various communications tools including social media to convey important messages to youth globally.
- Have time to dedicate to the Global Youth Committee and its network. This is not only a representative role, but the candidates will also be part of the team that does the work to make the Youth Committee work plan successful.
- Be 31 or younger so that they do not exceed the age of 35 during their four years in office.
